The WTR 1000 rankings remain the only standalone publication to recommend individual practitioners and firms exclusively in the trademark field, and it identifies the leading players in over 80 key jurisdictions globally. To research the market, WTR 1000 conducts face-to-face and telephone interviews and exchanges correspondence over a four-month period with hundreds of lawyers and their clients involved with trademarks. Written submissions from firms detailing recent activity in the field are also gathered. Individuals qualify for inclusion in the WTR 1000 upon receiving sufficient positive feedback from market sources with knowledge of their practice and the market in which they operate. Firms qualify for a listing on the basis of their depth of expertise, market presence, and the level of work on which they are typically instructed.
